

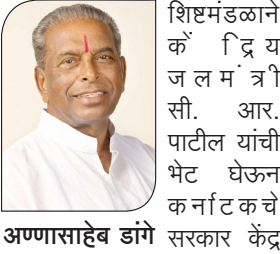

याबाबत घटनास्थळावरून मिळालेली अधिक माहिती अशी : अनिता मोहिते या मांजर्डे गावापासून दोन किलोमीटर अंतरावर असणाऱ्या मांजर्डे ते मोराळे रस्त्यावरील बारा आंबा मळ्यानजिक असणाऱ्या कव्हाप्पा मळ्यात सध्या घरात एकट्याच राहत होत्या. त्यांना एक मुलगी असून, ती मुंबई येथे राहते. गेले दोन दिवस मुलगी आई अनिता यांच्याशी फोनवरून संपर्क साधत होती, मात्र अनिता यांच्याकडून मोबाईलवर प्रतिसाद मिळत नव्हता. त्यामुळे मुलीने नातलागांशी संपर्क साधला. नातलागातील तरुण गुरुवारी रात्री सुमारे दहा वाजण्याच्या सुमारास अनिता मोहिते राहत असलेल्या मळ्यातील घरी गेला असता, दाराला आतून कडी होती. त्याने घराच्या मागील बाजूस जाऊन बघितले असता, मागील दार

मृतदेह सडलेल्या अवस्थेत आढळला

उघडे दिसले. त्याने दारातून आत जाऊन पाहणी केली असता, कांटवर अनिता या मृतावस्थेत दिसून आल्या. मृतदेह सडलेला असल्याने घरात मोठ्या प्रमाणात दुर्गंधी येत होती.
